NOTICE

It is hereby informed that the following residential premises within New Town have been found to be operating as Guest Houses/Fab Hotels/Banquets without obtaining the requisite permissions or statutory clearances from the competent authorities.

These operations have been found to be in violation of Notification No. 2287-UD/O/M/HID/5M-36/2014, dated 14th July, 2015 of the Urban Development Department, Government of West Bengal, which allows limited non-residential use of residential premises only with prior approval and compliance with all applicable norms.

Accordingly, the concerned parties have been directed to stop all such illegal Guest House/Fab Hotel/Banquet activities with immediate effect until further orders.

This step has been taken particularly from the prism of (fire) disaster management.


