ORDER OF NEW TEMPORARY/OCCASIONAL VEHICLE PARKING ZONE UNDER NEW TOWN KOLKATA DEVELOPMENT AUTHORITY

Whereas complains were coming from residents around Community Centre 1 and Fairfield hotel about disorderly and indiscriminate parking of vehicles on evenings of social events and the site was inspected by NKDA officials for a solution to the problem and discussion was held with the local management of Fairfield hotel, now with the approval of the competent authority of NKDA the following notification for parking on days of events in this region.

In the interest of public safety and convenience, in exercise of power vested with the New Town Kolkata Development Authority under Section 50(1) of New Town Kolkata Development Authority Act 2007 it is hereby notified that in addition to parking zones notified vide earlier notifications, the following stretch of Street Number 1111 (Biswa Bangla Sarani) will be NKDA "Fee Parking" zones as per time schedule noted, under New Town Kolkata Development Authority (NKDA). This order shall come into force with immediate effect and continue until further order.

Fee Parking

1111	Southern side of Southern Service Lane to Major Arterial Road /Biswa Bangla Sarani from Unbox Park to the East to Crossing of Street No. 240 to the West	On event days 24 hours special parking	Two wheelers and four wheelers parallel to kerb

Parking of vehicles should be made without obstructing flow of traffic on the carriageway and without obstructing the ingress and egress to plots/premises/property abutting the street. No Parking allowed within 3 meters of street crossings. Parking should be made in accordance with traffic rules and as guided by police as well as NKDA officials. NKDA reserves the right to change or relocate the parking zones at their discretion

The management of Community Centre 1 and Fairfield Hotels should inform at least a week earlier about the days of events to NKDA parking management section.

Fairfield hotels will pay Rs.6000(Rupees six thousand only) plus applicable GST per day of event to NKDA for these days. The charges may change subject to decision of the NKDA authorities.

3 security guards will be posted by NKDA on the days of the events to manage the parking.

Both sides of Street No. 193, 256, 195, 254 shall be no parking zones on these days.

No parking shall be allowed on the nonevent days when no parking sign will be displayed at the designated stretch.
