General Conditions:

- 1. The bidding documents must be sealed in an envelope super-scribing "SELECTION OF AIR RIFLE SHOOTING COACH"
- 2. Conditional quotation will not be entertained and will be summarily rejected.
- 3. After having been selected as a successful Coach / Agency on written intimation shall have to enter into an Agreement in duplicate on non-judicial stamp paper of Rs 10.00 (Rupees Ten), the cost of which would be borne by the Coach / Agency. The Coach / Agency shall be bound by the terms and conditions of contract to be executed along the specifications as enumerated. The Agreement / Deed of Contract shall be valid for a period of 11 (eleven) months from the date of signing the same. The Agreement can be renewed afterwards on mutual consent
- 4. The intending Coach / Agency should have the following minimum criteria for selection:
 - a. Experience Certificate of Air Rifle Shooting (last 5 years)
 - b. Diploma / Degree Certificate of Air Rifle Shooting
 - c. Proof of participation in Olympic Trials

- 5. The intending Coach / Agency should also submit photocopy of the following documents:
 - a. PAN Card
 - b. Aadhar Card
 - c. Professional Tax with paid Challan of the current FY
 - d. Valid Trade License & GSTN Certificate (for Agencies only)
- 6. Each page of the requisite documents must be stamped and signed by the person / authorised persons submitting the bid in token of his / their having acquainted himself / themselves and accepted the entire bid documents including various conditions of empanelment

Scope of Work & Conditions:

- 1. The revenue generated each month by way of coaching fees of students for a particular sport will be shared between NTBC and the selected Coach / Agency in the ratio of **51%:49%** respectively after deduction of GST @ 18%. The payment to the Coach / Agency will be made after completion of each month within 7 (seven) working days of the following month by way of a crossed cheque drawn in favour of the Coach / Agency or by online transfer.
- 2. All students will pay the fees due to them by card / online transfer / UPI to New Town Business Club by the 10th of each month, students failing to pay would be debarred from training for that month. The same student may however join the class next month after paying the requisite fees to NTBC
- 3. The Coach / Agency will be imparting training to the students for 2 (two) days a week i.e Saturday evening and Sunday full
- 4. The Authority will bear absolutely no financial liabilities
- 5. The Authority will not be responsible for any injury (fatal / non-fatal) occurring to any student in the course of training imparted
- 6. The Authority reserves the right to terminate any or the entire empanelment list without assigning any reason thereof. The empanelment may be rescinded at any point of time due to bad conduct on the part of Coach / Agency
- 7. On approval of selection, the Coach / Agency is required to sign an Agreement with GM, NTBC. The same may be terminated in case of irregularities / under performance / non-adherence to Govt Orders / suppression of facts by giving one-month notice from the Authority
