The interested agency should have experience of working preferably under Govt. Departments regarding various civil infrastructural facilities and may participate by way of offering response in the prescribed format as appended hereto in Annexure – I. All information contained in this EOI & that will be subsequently provided/clarified are in good interest and faith. The applicants should also make their own independent investigation in relation to any additional information that may be required. This is not an arrangement and is not an offer or invitation to enter into an agreement of any kind with any party and the information provided at this stage is merely indicative. BACKGROUND:-

New Town is expanding rapidly and for this declared green & smart city which is being visited by more than one lakh of floating population regularly for official or personal reasons, provision of good quality, clean & hygienic community toilets is very essential especially for the women, elderly & physically challenged people. These toilets shall have modern amenities like waiting area, running hot/cold water, auto clean system, locker room and also an arrangement for easy accessibility of physically challenged people.

SCOPE OF WORK & SPECIAL CONDITIONS:-

- New Town Kolkata Development Authority which is the Urban Local Body (ULB) under the Deptt.
 Of Urban Development & Municipal Affairs, Govt. of West Bengal shall provide the land of area
 100 110 Sq. m opposite to the Axis Mall, New Town and adjacent to Novotel for a period of 25
 years on lease.
- 2. The plan and design of the Community toilet as prepared by the agency has to be submitted to the authority for approval. After approval construction work shall be taken up accordingly and has to be completed within a period of three months.
- 3. The agency shall run and maintain this pay & use Community toilet and compensate an amount of Rs, 12000/- annually to NKDA with an increment of 5% for each subsequent year. New Town Kolkata Development Authority will under no circumstances be held responsible for the project being non successful in respect of the expected number of beneficiaries/income of the agency and other consequences and will bear no financial liabilities.
- 4. Commercial tax, Electric bill, Water tax and any other tax which may crop up in future shall have to be paid by the agency.
- 5. The agency has to pay 15% of the amount to NKDA which may be earned through advertisements utilizing the proposed structure of the Community toilet.
- 6. The agency will have to adhere strictly to the rules and regulations of the New Town Kolkata Development Authority in all regards.

GENERAL CONDITIONS:-

- 1. The sealed documents should be dropped in the Tender Box at NKDA office on or before the stipulated date and time.
