1) Manpower Requirement

- c) 03 no Security Person round the clock in 3 shifts of 08 hours each
- d) 03 (three) Multi Tusk Worker (M.T.W) having expertise in Dog caring one each for 3 shifts of 8 hours round the clock.
- e) 03 (three) Personnel for sweeping, Caring, cleaning, round the clock one each for 3 shifts of 8 hours.

- c) Engagement of Round the clock Security Personnel.

- b) Dog Squad consisting of 02 expertise persons with suitable instruments and Vehicle for Catching stray Dog from the Jurisdiction of NKDA area and transporting them to the Dog Pound.
- c). Three Multi Task Worker having expertise in Dog keeping and caring round the clock (1 for each shift)
- d). Three sweeper-cum-Caring Staff round the clock (1 for each shift.)
- e) Day to day feeding, treatment and caring of the Dogs
- f) The Agency on their part will place the claim to the Authority for incurring expenditure for the above works. and **Quote Yearly Bid amount** for three years.
