An Expression of Interest (EOI) is hereby invited by the General Manager, New Town Business Club, from the bonafide resourceful Caterers, who are registered, having good track record with experience of at least 5 (five) years and possess a valid Trade License in their own profession for "Empanelment of Caterers" for various programs in the New Town Business Club, New Town Kolkata, street No.90, Block AE, Action Area-1, New Town and New Town Banquet Hall on Street No.124, Block BG, New Town.

#### BACKGROUND

New Town Business Club or NTBC an initiative of NKDA has started functioning from 26-7-2016 and presently having a membership count of about 2500 members and their families.NTBC has been able to arrange various outdoor and indoor games like Lawn Tennis, Badminton, Squash,Shooting,Skating,Swimming,TableTennis,Dart, Billiard and over and above Gym facilities for upholding physical fitness of its Members. The intending bidders have to deposit a onetime non-refundable Empanelment Fee of Rs 5,000.00 (Rupees Five Thousand) only plus GST @ 18% for the tenure of Empanelment i.e. six months (extendable by another six months on mutual consent), in favor of "NEW TOWN KOLKATA DEVELOPMENT AUTHORITY" in the form of Bank Draft/Pay Order, payable at Kolkata and at the time of submission of documents
  - 3. The empaneledcaterer should have prior knowledge about the NTBC / NKDA and its facilities for parties / programs
  - 4. Green landscaping, pathway, structure and all other facilities available should not be damaged in any form. Penalty will be imposed if such damage or deformation is noticed after the completion of program. Penalty would be imposed @ of twice the cost of repair/destruction caused



- 5. Non-empanelled caterers may be empaneled for six months (extendable by another six months on mutual consent), to provide catering services to New Town Business Clubvenues on payment of anon-refundable Empanelment Fee of Rs 5,000.00 (Rupees Five Thousand) only plus GST @ 18% in addition to the plate money as given in the following para.
- 6. The empaneled caterer would be required to pay a Guaranteed Plate Money @ Rs 50.00 (Rupees Fifty) per plate or Rs.30.00 per packet inclusive of GST for events conducted at Green Verge Banquetor The Club Banquet near New Town Bus Terminus.
- 7. The empaneled caterer will also be responsible for distribution of food to the customers through properly levered and trained waiters. There will be no compromise on the quantity and quality of food supplied and that the empaneled caterer would have full onus in case of any complaint
- 8. The empaneled caterer has to clean and remove allwaste materials including kitchen waste after completion of the event and must be completed by 7:00AM of the next day
- 9. The empaneled caterer should collect all necessary statutory licenses if required for the event.
- 10. After submitting EOI, the selected caterer to be empaneled has to sign an Agreement on a Non-Judicial Stamp Paper with NTBC, valid for one year, the cost of which will have to be borne by themselves
- 11. The empaneled caterer will have to abide by all the decisions of NTBC / NKDA, which shall be final.
