
#### BACKGROUND

- 3. The empanelled Agency should have prior knowledge about the NTBC and its facilities for the program.
- 4. No permanent structure will be allowed for any event management program. Only portable structure will be used for decoration and that should be removed out after each and every event by 7:00 AM on the next day.
- 5. Green landscaping, pathway, structure and all other facilities available should not be damaged in any form. Penalty will be imposed if such damage or deformation is noticed after the completion of any event management program/decorating work. Penalty would be imposed @ twice the cost of repair/destruction caused.
  - 6. Cleaning and removing of waste materials after completion of the event.
- 7. The empaneled Agency should collect all necessary statutory licenses if required for the event.
- 8. After submitting EOI, the successful bidder will sign an Agreement on a Non-Judicial Stamp Paper with the Club Authority, valid for one year, the cost of which will be borne by Bidder.
