Departments having experience in the similar nature of Design, development and maintenance of NKDA's Toto/ e-rickshaw ride sharing app by modern technology and skilled manpower and are requested to submit their offer for the work detailed below.

## 8. EoI Details:

Specifications for Developing NKDA's One City One App/Scope of Work

#### 8.1 Job Description

#### a) About NKDA

The New Town Kolkata Development Authority has been constituted under The New Town Kolkata Development Authority Act, 2007 (The West Bengal Act XXX of 2007) for rendering various civic services and amenities within New Town, Kolkata and it has come into effect since November, 2008.

## b) Core expectations from the service provider

i. NKDA is proposing to develop a mobile app for Toto Ride Sharing in Android/iOS which shall be a ride hailing app for Toto by citizens and enable discovery of available toto by citizens for rides. The Play store/ iOS account expense shall be borne by the selected vendor. The admin shall have access to a dashboard to view all available toto locations, view emergency alerts by riders, register/ de-register any

toto, control toto stand information, add/ remove toto stands and control the online payout mechanism etc.

- ii. The solution must enable booking totos from toto stands based on the queue position in the toto stand (FIFO) and totos plying in the streets as well as (in case non-availability of Toto's in the stand)
- iii. Four modules are envisaged in the solution:
  - a. Citizen App: Check Availability > Connecting to TOTO Driver > Raise Complain/ dispute/ alerts
     > Pay drivers
  - b. **Toto Driver App:** View requests for ride > Accept/ Reject > Online/ Offline Payment > Duty Status ON/OFF > Status (In toto stand to be booked as per queue position/ Plying in street)
  - c. Toto Stand Manager App: QR CODE in stand for Toto drivers to register queue position (FIFO)
     Controlling Queue > De-Queuing of TOTO > Admin to Add or Remove TOTO from Specific Stand > Raising e-KYC Request for New TOTO Driver. This APP will be optional depending requirement of Toto Stands.
  - d. Admin Dashboard for NKDA: NKDA KPI View > See All Live TOTO Locations > Control & Pass Any Emergency by Rider > De-register any TOTO > Register or Accept New TOTO e-KYC Request > Control TOTO Stand Information > Add/ Remove New Stand > Add/ Remove Stand > Control online payment mechanism.
  - e. **Integration with ICCC of New Town Kolkata** Necessary API to be provided for integration with ICCC platform of NKDA. KPI for data, alerts are to be define during preparation of SRS.
  - f. Proving necessary API for booking, necessary payment through upcoming one city one app.
- iv. The selected vendor must design the detailed workflow to improve the above indicative processes.
- v. The Toto App shall have OTP as well as email/ password-based login. Only SMS gateway shall be provided by NKDA.
- vi. Service provider would provide end-to-end managed services for development and maintenance of the app/ web-app. Along with its usual core skills, the service provider will be required to position NKDA's app with
  - (a) online payment mechanism
  - (b) visually attractive and easy to navigate design
  - (c) Training modules for usage of app including in-app graphical tutorials, text and video-based tutorials.
  - (d) Map view of available totos

- vii. The App must have provision to display ads such as video/ images for revenue generation for NKDA. Admin dashboard should have the provision for enabled or disabled ads.
- viii. The app provides for/wishes to provide additional facilities to users such as automatic acknowledgements for feedback submitted, destination and source selection, search option for totos including advanced search option.
- ix. The admin dashboards should be compatible with all common web-browsers and Operating Systems on PC, Mobile and Tab platforms.
- x. The dashboard should provide NKDA with system generated monthly, quarterly and other reports as and when asked by NKDA to check app traffic details including details of users, rides requested/booked/rejected, increase in traffic, most searched etc. The solution should be complaint with W3C standards on "Web design and application".
- xi. The service provider should provide NKDA with a module/ programme that tracks every change/update made in the app by mapping the IP address, username etc. of the personnel effecting the changes.
- xii. The service provider should ensure that the app is safe for malware activity/ hacking/ defacing attempts. The onus of installing the latest software to achieve this goal will be on the agency during the entire term of engagement.
- xiii. Hosting of the app in a MeITY empaneled Cloud Service provider. Server specification to be provided by the service provider. System should accommodate at least 1000 co-current user.
- xiv. Maintenance & necessary updation of the app for the entire period of contract.
- xv. A team member is to be assigned **permanently** for the duration of the contract to collect data from various toto stands, train the toto drivers for on-boarding into the app, resolve emergency alerts and address payment failures. During on-field support a minimum of 100 totos/ autos are to be on-boarded and trained by the vendor.
- xvi. An on-boarding cum training camp is to be held every quarter for 3 years (12 nos.) for Toto drivers and citizen users. Support is to be provided in case any other camp is organized by NKDA.
- xvii. The vendor is to provide support for the duration of the contract to resolve emergency alerts and address payment failures.

## c) Updating requirements on the app

- I. Change Requests: NKDA shall submit change requests for application modification from time to time
- II. The app should be able to receive and convey updated information without any time lag.
- III. Maintaining strict confidentiality of all customer and driver details is an absolute prerequisite.

IV. Administrative dashboard and other modules may be needed to be changed based on in-field observations, learnings, government regulations and best practices

## 8.2 Platform and Database

- a) The ownership of entire data hosted in NKDA's app, in all forms including text, data, graphics, animations, audio/video content, etc., rests only with NKDA. Similarly, the ownership of all source codes of software used for the purpose of hosting the contention NKDA's official app would rest with NKDA. NKDA reserves the right to change the service provider for maintenance with one-month notice period.
- b) The app will be hosted on MeITY empaneled Cloud servers for the entire period of contract with a backup copy on NKDA server.
- c) Registration Data is to be received through in-app forms. Photographs are to uploaded of drivers in JPEG or other formats. Discount facility may be enabled as decided by NKDA.

#### 8.3 Some Requisites

- a) The app must be available 24x7x365 with 1% downtime tolerance. Security and integrity of the database and the app has to be maintained under all circumstances.
- b) Timeliness, uninterrupted service, volumes, quick response time and confidentiality are uncompromised requirements of the NKDA app. User friendliness is an equally important feature of the site.
- c) There is no scope for error in placing information on the app at the scheduled time, neither before nor after, and keeping it confidential till then NKDA considers error in this to be a reputation risk for itself and, therefore, unacceptable.
- d) **Go-Live**: The service provider is required to complete development of the new app by 3 months including design, redirecting to relevant webpages, patch VAPT anomalies, Security audit by CERT-In emplaned agency.
- e) Enhancement of the features of the app should be a continuous exercise.
- f) Interactive modules/ portals to be added with provisioning for incorporation of modules with a special focus on present and future requirements.
- g) Quick support in all days in case of any technical and operations issues.

#### 8.4 Back-up and audit of app

a) Back-up of the app with all content, script, software and other files is to be provided to NKDA on a monthly basis.

- b) The service provider will be responsible for installing anti-hacking/phishing related software.
- c) Each service provider should prove his ability to provide the following technical services/ meet the technical expectations in a clear manner in the same sequence as specified below:
  - i. Should have expertise in configuring, installing and maintaining licensed software (if any) required for proper hosting of app with latest anti-virus with all critical updates to be installed in the server.
  - ii. All software should be regularly patched/ updated.
  - iii. The service provider should use SLA metric for back-up and maintenance.
  - iv. Service provider should have a governance structure in place to report to NKDA's team on daily, weekly and monthly basis and the solution should allow downloading of standard and custom reports on the monitoring status.
  - v. Service provider should do 24X7X365 security monitoring of NKDA's app developed by them (coding point of view) to detect attacks and alert about suspicious events that may lead to breach of security.

## 8.6 Eligibility Criteria/Who can apply?

- a) A company/ partnership firm/ proprietary firm which shall provide evidence that it is a current legal entity in India, with impeccable repute in managing equally large and data-oriented apps, with at least 5 years' experience in managing similar android/iOS apps.
- b) The bidding company/ partnership firm/ proprietary firm must warrant that no legal action has been taken or being undertaken against it for any cause in any legal jurisdiction. **Declaration to be submitted**.
- c) The bidding company/ partnership firm/ proprietary firm should have a development office in Kolkata along with personnel for designing, coding and data base management team in house. Details (CV) of the manpower to be uploaded.

- e) A company/ partnership firm/ proprietary firm should have the **minimum average turnover of Rs 50 Lakhs** in software developmental work in last 3 (three) financial year. Copy of the balance sheet to be uploaded last 3 (three) financial year
- f) A company/ partnership firm/ proprietary firm upload bank solvency certificate of Rs 5,00,000/-.
- g) Selected service provider shall appoint a single point of contact with whom NKDA will interact and should be subject matter/domain experts to interact with the technical team in NKDA.
- h) Joint Ventures/MOU will not be allowed as credential.

Since the ownership of the source code used for customizing and hosting on NKDA's app rests with NKDA, the source code must be handed over to NKDA immediately after completion of development and porting of the data. Whenever, there is any modification/addition in the source code during warranty/ AMC period, the modified/ changed source code must be handed over immediately to NKDA. The

ownership of source code and related Intellectual Property Right (IPR) with reference to NKDA's corporate app will lie with NKDA only.

## 13. Signing of Contract

The tenderers are bound by the terms & conditions of WBF 2911(ii) along EoI, terms & condition, Information to Bidders, Schedule of works etc, which forms a part and parcel of this contract.

#### 14. Penalties

- a) The service provider will provide the app designing and other services as per the service level specified in EoI. In case these service level scan not be achieved or the inability of the proposed services (entire IT Infrastructure provided by the service provider for example hardware, software etc.) to meet the scope of work as defined in the EoI document, delay in implementation and roll out or deliver the required functionality at service levels defined in this EoI at the specified volumes shall result in a breach of contract and invoke the penalty clause.
- b) In case of delay in Design, development and go-live of the app within 3 (three) months of the issue of work order, then a sum equivalent to 1% (one percent) of the total contract value shall be deducted from the payment for each calendar week of delay or part thereof.
- c) In case of maintenance support for the contents of the App, a penalty of Rs 5000 (Five thousand) per day will be levied if the support is not provided within 24 hours of the call being logged.

## 15. Right of NKDA to accept or reject the bid

- a) NKDA reserves the right to accept/reject any or all offers submitted in response to this without assigning any reason whatsoever.
- b) NKDA reserves the right to short-list the service provider based on the requirement of this authority and may call service providers for a presentation or otherwise before an evaluation committee, at service provider's cost.
- c) NKDA shall be entitled to terminate the agreement with the service provider at any time giving 30 days prior written notice to the service provider if the service provider breaches its obligations under the EoI or the subsequent agreement and if the breach is not cured within 15 days from the date of notice by NKDA.

#### 16. Effect of Termination

The service provider agrees that it shall not be relieved of its obligations under the reverse transition mechanism not with standing the termination of the assignment.

Reverse Transition mechanism would typically include service and tasks that are required to be performed/rendered by the service provider to NKDA or its designee to ensure smooth hand over and transitioning of NKDA's deliverables and maintenance. The reverse transition will be for the period of 1 month post the notice period.

- a) Same terms (including payment terms) which were applicable during the term of the contract should be applicable for reverse transition services.
- b) In case the NKDA wants to continue with the service provider's services after the completion of this contract then the service provider shall offer the same or better terms to this authority. Unless mutually agreed, the rates shall remain firm.
- c) This authority shall make such prorated payment for services rendered by the service provider and accepted by NKDA at the sole discretion of NKDA in the event of termination, provided that the service provider is in compliance with its obligations till such date. However, no payment for "costs incurred, or irrevocably committed to, up to the effective date of such termination" will be admissible. There shall be no termination compensation payable to the service provider.
- d) Termination shall not absolve the liability of NKDA to make payments of undisputed amounts to the service provider for services rendered till the effective date of termination. Termination shall be without prejudice to any other rights or remedies a party may be entitled to hereunder or at law and shall not affect any accrued rights or liabilities or either party nor the coming in to force or continuation in force of any provision hereof which is expressly intended to come into force or continue in force on or after such termination.

## 17. Liability of the selected service provider

- a. NKDA shall hold the selected service provider fully liable against loss or liability, claims, actions or proceedings, arising out of non-fulfilment of any obligations under the contract.
- b. Selected service provider shall be the principal employer of the employees, agents, contractors, subcontractors etc. engaged by Selected service provider and shall be vicariously liable for all the acts, deeds or things done by its employees, agents, contractors, sub-contractors etc., whether the same is within the scope of power or outside the scope of power, vested or instructions issued by the NKDA under the contract to be issued for this EoI. Such liability of the Selected service provider will be restricted to the actual amount of the contract.
- c. However, the selected service provider would be given an opportunity to be heard by NKDA prior to making of a decision in respect of such loss or damage.
- d. "Not withstanding anything to the contrary elsewhere contained in this or any other contract

between the parties, neither party shall, in any event, be liable for any indirect, special, punitive, exemplary, speculative or consequential damages, including, but not limited to loss of income or profits."

#### 18. Pricing

It is absolutely essential for the service provider to quote the lowest price at the time of making the offer in its own interest. In the event of NKDA not satisfied with the Price Discovery in this process, this authority reserves the right to initiate the tendering process again through Limited or Open EoI.

## 19. Information Ownership

All information processed, stored, or transmitted by service provider be longs to NKDA. The service provider understands that civil, criminal, or administrative penalties may apply for failure to protect information appropriately.

## 20. Publicity

Any publicity by the service provider in which the name of NKDA is to be used should be done only with the explicit written permission of NKDA.

## 21. Privacy & Security Safeguards

The service provider shall not publish or disclose in any manner, without NKDA's prior written consent, the details of any security safeguards designed, developed, or implemented by the service provider under this contract or existing at any this authority. The service provider shall develop procedures plans to ensure that IT resources leaving the control of the assigned user (such as being reassigned, removed for repair, replaced, or upgraded) are cleared of all NKDA data and sensitive application software. The service provider shall also ensure that all subcontract or who are involved in providing such security safe guards or part of it shall not publish or disclose in any manner, without NKDA's prior written consent, the details of any security safeguards designed, developed, or implemented by the service provider under this contract.

#### 22. Non-Disclosure Information

The selected service provider shall not, without NKDA's prior written consent, disclose any specification, Software Requirement Specification (SRS), drawing, design sample, or information furnished by or on behalf of NKDA in connection therewith, to any person other than a person employed by the service provider in the performance of the work assigned to them. The selected service provider shall be required to sign a Non-Disclosure Agreement/Confidentiality Undertaking with NKDA as per the prescribed format provided in Annexure-III.

- 23. Prospective applicants are advised to note carefully the eligibility criteria before tendering the bids.
- 24. Conditional / Incomplete EoI will not be accepted under any circumstances.

- 25. The intending tenderers are required to quote the rate online.
- 26. During scrutiny, if it comes to the notice of the EoI inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the EoI and that application will be rejected without any prejudice.
- 27. If any discrepancy arises between two similar clauses on different notification, the clause superseding others will be solely as per the discretion of the EoI inviting authority.
- 28. In case of any inadvertent typographical mistake in the specific price schedule of rates, the same will be treated to be so corrected as to confirm with the prevailing relevant schedule of rates and/or technically sanctioned estimate.
- 29. NKDA will not be held responsible for making payment against any anticipated profit and/or compensation for any losses or price escalation whatsoever for the works as stated in the annexure of this NeIT. Rates should be quoted accordingly.
- 30. Arbitration clause of WBF 2911(ii) stands deleted, Settlement of disputes & arbitration shall be according to the 'Memorandum' for the modifications of clause relating to settlement of disputes under conditions of contract vide no. 8182-F(Y) dated: Kolkata, the 26th September, 2012 of Secretary to the Govt. of West Bengal, Finance Department, Audit Branch.
- 31. Before issuance of WORK ORDER, the EoI Inviting Authority may verify the credential and other documents of the lowest tenderer in original, if found necessary. After verification if it is found that the documents submitted by the lowest tenderer is either manufactured or false in that case work order will not be issued in favour of the said Tenderer under any circumstances and his/their offer will be treated as cancelled.
- 32. Any Corrigendum, notification in connection to this EoI will be published in the official website of New Town Kolkata Development Authority (www.nkdamar.org) as well as https://wbtenders.gov.in. The applicants are requested to please follow the websites for such notifications, corrigendum etc.
