#### **GENERAL TERMS & CONDITIONS:**

- 1. Conditional quotation will not be entertained and will summarily be rejected.
- 2. Service of Ambulance is to made within 7(seven) days from the date of issue of work order.
- 3. The undersigned reserves the right to accept or to reject any or all the quotations without assigning any reason whatsoever.

#### **PAYMENT TERMS:**

- 1. The payment shall be made on monthly basis on submission of bills in triplicate along with log book countersigned by authorized representative of NKDA.
- 2. Rate is inclusive of all taxes (including GST) and other duties.
- 3. Payment of fuel and lubricant will be made as per Govt. norms depending upon the running of the Ambulance.

#### SCOPE OF WORK :

- 1. Ambulance is to be provided under control of Health Centre of NKDA at Eco Park.
- Rate should be quoted including remuneration of driver and other consumables except fuel and lubricants for which payment will be made as per Govt. norms depending upon the running of the Ambulance.
- 3. Timing will be 24x7.
- 4. A Log Book is to be maintained stating details of the journey and same is to be countersigned by the Medical Officer, NKDA.

- 5. Interested Bidders should have Valid Registration Insurance, Pollution Control Certificate, Valid Driving Licence etc. Copies of these are to be enclosed with the proposal.
- 6. They should have experience to run at least one Ambulance in Govt./Semi-Govt. Organization for at least one year. Copy of this is to be enclosed with the proposal.
- 7. Contract period initially for a period of 3(three) months which may be extended for the further period at the discretion of the Authority.
- 8. The Ambulance should have minimum Life Support Facilities.
