- 6.1. The bidder shall have an experience of at least 5 years or more in similar type of work. The bidder shall submit necessary work order from any 3(three) Govt. Departments for website design & maintenance with completion certificate.
- 6.2. The bidder should have a valid trade license showing office in Kolkata.
- 6.3. The bidders shall have to submit their audited financial statement / audited annual report of the last three financial years.

- a) For Dedicated Server: Payment will be made on Half yearly basis on submission of server detail, log report, up-time report.
- b) For SSL certificate and configuration of different security toll like Anti-Spam:
  - 100% payment will be made on renewal of SSL

#### 9. Scope of Work

# A. Annual operation maintenance and up-gradation of existing website of NKDA

- a) Application maintenance contract cover alterations, updates and repairs, in addition to completing all maintenance requests, your contract includes internal and external links, on-line forms, search facilities, site maps and any dynamic functionality.
- b) Services covered in Annual Maintenance Packages are:

- Maintenance and up-gradation of existing website and Hosting & Maintenance of NKDA official website in existing dedicated server for a period of one (01) year.
- Code update time to time.
- SMS & Email gateway integration.
- Time bound support as per SLA.
- Upgradation of operational changes during the period.
- c) Monthly review to be conducted at the office of this Authority or Virtually, with team lead and developer:
  - 1. Review all the work undertaken by the bidder
  - 2. Progress of all the work
  - 3. New work to be undertaken by the bidder.
- d) Preparation documentation of the website to under the scope of the bidder.
- e) After completion of the contract bidder have to handover all the documentation (Hardcopy/ Softcopy), source code (DVD) for the final payment.
- f) Support will be 7 days basis in a week. In case of holiday, bidder have to complete the job on urgency basis. Failure of that, necessary penalty will be deducted as per the Service Level Benchmark (SLA).

# B. Hosting & Maintenance of NKDA official website in dedicated server for New Town Kolkata Development Authority

- d) Configuring security tool like Anti-Spam ware in the server.
- e) Submissions of detailed report sever security to be submitted.
- f) Dedicated server should have web console with necessary permission.
- g) The server should be available 24 x 7 hrs. Declaration to be submitted about the availability.
