The quotationer whose quotation may be accepted shall within 7 (Seven) days from the date of Work Order deposit with NKDA a sum which with the earnest money already deposited will be equivalent 10 (Ten) Percent of the total accepted value of the materials to be supplied under the contract, as Security for due performance of the contract. Deposit is to be made in the same manner as specified in (1) above at the time of making agreement.
- 3. The successful quotationer to whom work order /supply order will be issued, shall be treated as contractor under the contract.
- 4. The Contractor is to deliver the materials on or before the dates mentioned in this NIQ. Failing which he shall be bound to pay 1 (one) percent on the total amount of the contract for every day not exceeding 10 (Ten) percent for 10 (Ten) days that the contractor shall

exceed the time, for delivery as and by way of liquidated damages or for such an amount as the Competent Authority may in his discretion reduce to such smaller amount as the Competent Authority may decide and his decision in writing in that respect shall be final.

- 5. Security Deposit Money of L1 may be refunded in the manner as prescribed below,
 - (i) Part Security Deposit equivalent to the accepted value for supply & delivery of non- wooden material After 1 (one) month from the date of delivery.
 - (ii) Balance Security Deposit equivalent to the accepted value of wooden material After 6 (six) months from the date of delivery.
- 8. Statutory deduction(s) towards IT as well as other statutory deductions (s), if any, will be made from the bill.
