- Conditional quotation will not be entertained and will be summarily rejected.

General Terms and Condition:

01. The general scope of the work includes:

- 1.1 In the event of any loss caused by accident/incident during the transportation of materials and exhibition, the same shall be borne by the contractor. He shall not be entitled to get any compensation or claim from the NKDA for any loss to his/her men & materials, articles, dead stock, furniture, fixture, cloth, due to natural calamities which is beyond the control of the authorities.
- 1.2 During the period of construction/exhibition, the contractor shall have to make his/her own arrangement for facilities like water, electricity, storage, security etc.
- 1.3 The contractor will be responsible for up-keep maintenance of installation & security arrangement of entire structure constructed by him/her , for which no extra payment shall be made. Breakage and damage, if any, shall immediately be replaced / repaired without any extra cost..
- 1.4 The contractor must obtain necessary clearance from the statutory authorities as per rules and possess necessary licences and permits for execution of such jobs.
- 1.5 Materials used and procedure of adoption must conform to relevant codes and statutory requirements and should be high in standard.

- 1.6 The contractor shall engage technically qualified architects / engineers and experienced supervisors/ personnel for executing the work.
 - 1.7 The bid should be accompanied with documentary evidence showing that the bidder being a registered/approved government contractor and has done similar nature of work at least for last 3 years.
 - 1.8 The bidders, in their own interest, are advised to inspect the site of and ascertain its physical condition before submitting bids.
 - 1.9 Payment shall be made on completion of the work subject to the physical verification to be done by the concerned officers of the NKDA within a month of conclusion of the mela.
 - 1.10 The lowest bidder in **GRAND TOTAL** will be entertained.
 - 1.11 On completion of the work, the contractor must remove all the installations immediately.
 - 1.12 Statutory deduction(s) towards IT as well as other statutory deductions (s), if any, will be made before making payment.
 - 1.13 The bidder(s) will not be allowed to sublet the work to any other contractor for providing any component during the Seminar. Likewise, no co-sharing of the job will be permitted.
02. Interested bidders are hereby requested to furnish their proposals/rates through two bid system i.e. Technical Bid and Financial Bid for the entire work.r.
 03. The Technical and financial terms and conditions of shall be as follows:
 - 3.01 The company should produce the self attested photocopies of documents related to allocation of Registration Number, PAN Number, Service Tax number, P.T clearance certificate, valid document in support of enlistment, S.T clearance certificate.
 - 3.02 For any item /services not quoted, the highest quoted rate from other bidders will be loaded to the item by default. However, in case of successful bidding, the bidder shall execute the work/service at the lowest quoted rate.
