- 3.1 The bids received without prescribed performance certificate shall be rejected.
- 3.2 Validity of the contract: The period of contract shall be for a period of 01 (one) year from the date of issue of the work order.
- 3.3 Conditional Tender will not be entertained and shall be deemed as 'informal'. In case of any conditional bids the Earnest Money will be forfeited.
- 3.4 The quotes rate should be per cattle capture basis which includes manpower and transportation cost, if any
- 3.5 The rates should be mentioned in figures as well as words
- 3.6 TDS and any other Government levies applicable shall be deducted from bill amount as per rules and instruction issued from time to time.

Scope of work.

- 5.1. Capturing of Cows and Buffalos from MAR and Internal Roads of New Town Kolkata including carrying the same in the Cattle Pound at Plot No. OPC-24/1 of AA-ID, New Town Kolkata by arranging own vehicle.
- 5.2. Food, Water, Medication, as required, to be arranged for Cattle during captured time.
 - 5.3. Placing the captured Cows and Buffalos inside the Pound.
 - 5.4. Treatment of Cows and Buffalos, as required, within limit during captured time.
- 6. The bidder have to submit 03 (Three) sealed separate envelopes respectively, for 'Technical Bid', ';Financial Bid' and EMD in a big outer sealed cover supercribed 'Capturing of Stray Cows and Buffalos from MAR and Internal Roads of New Town including carrying the same inside the Cattle pound located in Plot No. OPC-24/1 of AA-ID maintained by NKDA'

7. Mode of Selection:

The evaluation of the Technical bids will be carried out in the following manner.

- (i) Technical Bids will be evaluated of only those bidders who fulfil the eligibility criteria.
- (ii) Required document list.
- (iii) Past experiences.

8. BID Prices:

The bidders shall have to quote bid prices on the appropriate format for 'Financial Bid Document' enclosed as part of bidding document.

9. Mode of Payment.

Payment will be released on monthly basis based no. of cattle captured and carrying the same inside the Cattle Pound as stated above.

10 Opening of the Tender.

Tender shall be opened as per date and Time Schedule. In case Tender opening date is declared Holiday, tender shall be received and opened on next working day at the same time specified.

- The offer shall remain valid for 180 days from the date of opening of the tender.
- 12. The Bidder will have to submit a token EMD of Rs 10, 000.00 (Rupees ten thousand) only in the shape of Demand Draft with any Nationalized / Scheduled bank in favour of New Town Kolkata Development Authority" payable at KOLKATA. For the successful bidder remaining amount to complete the EMD @ 2% of the quoted rate has to be submitted at the time of agreement and shall be retained with NKDA till the Security period is over . For an unsuccessful bidder the token EMD will be refunded after completion of the process.
- 13 The bidders are bound by the terms & conditions of EOI document which forms a part and parcel of this contract.
- 14. Prospective applicants are advised to note carefully the eligibility criteria before bidding.
- 15. Conditional/Incomplete bid will not be accepted under any circumstances.
