# NOTICE INVITING e-TENDER Notice Inviting e-Tender No. 04 /NKDA/ADMN/2017.

#### 5) Eligibility

- a. The bidder shall have an experience of at least 3 years or more in this field. The bidder should submit a performance certificate from any 2 Govt. Departments/ PSUs/any other reputed organizations. The bids received without prescribed performance certificate shall be rejected.
- b. The bidder should have a valid licence to stock and use of permissible insecticide for commercial pest control operation.
- c. The bidders shall have to submit their audited financial statement / audited annual report of the last three financial years.
- d. The bidders should be able to provide at least 6-8 sets of both sprayer and fogging machines per day. Manpower 10-12 heads should be available for providing such services.
- e. Xerox Copy of Valid Trade Licence/Sales Tax/Service Tax Registration Certificates/PAN Card to be enclosed with the quotation.

#### 6) Earnest Money Deposit (EMD)

The bidder shall furnish an amount of Rs.1,00,000/- (Rupees One lakh) only as Earnest Money by way of Demand Draft/Pay Order drawn in favour of "New Town Kolkata Development Authority" payable at Kolkata which shall be converted into the Security Deposit and to be refunded on expiry of contract period. The said Security Deposit will be forfeited if the contractor fails to perform his contractual duties satisfactorily. The EMD of the unsuccessful bidder will be discharged/returned on completion of tender formalities. In case the NIeT is required to be re-invited, the existing EMD may be submitted.

#### 7) Terms and Condition

- a) **Validity of the contract**: The period of contract shall be for a period of 12 months from the date of issue of the Work Order.
- b) Agencies are advised to visit the place of work for assuring the nature and volume of work realistically before quoting the rates.
- c) Conditional tender will not be entertained and shall be deemed as 'informal'.
- d) The quoted rates should include the cost of pesticides and related labour and transportation charges. No other charges except the quoted rate will be paid.
- e) The rates should be mentioned in figures as well as in words exclusive of taxes and levies.
- f) TDS and any other Government levies applicable shall be deducted from bill amount as per rules and instructions issued from time to time.
- g) The undersigned reserves the right to refuse permission to issue tender papers without assigning any reason what so ever and no challenge against such refusal will be entertained.
- h) The Tender Inviting Authority reserves the right to deny or accept or reject any or all the bids and even to annul the tendering process at any point of time without prejudice to further action and without assigning reason thereof.

#### 9) SCOPE OF WORK

- a) Mosquito Control means by using Bacillus thuringiensis var israelensis (BTI) as mosquito larviciding agent through Hand Compression Machine/Bolo Power Sprayer and Fumigation through Fogging Machine using Pyrethrins chemical as per recommendation of National Vector Borne Disease Control Programme (NVBDCP), Government of India and WHO. Kerosene oil to be sprayed on stagnant water at construction sites and vacant plots.
- b) The pesticides, etc. used for pest control, should not have adverse impacts on human health.
- c) The bidders should be able to provide at least 6-8 sets of both sprayer and fogging machines per day. Manpower 10-12 heads should be available for providing such services.
- d) Area to be cover: Entire area under jurisdiction of NKDA.
- e) Spaying / Fogging to be done on regular basis even on holidays as per weekly calendar/schedule to be provided by NKDA .
- f) Images to be captured for each pest control locations and to submit to concerned whatsapp no.

- g) Work done certificate from Authorized representative of the location/ area/ housing complex/ Supervisor of NKDA is required to be submitted on daily basis. Job completion certificates and images (in DVD format) to be submitted along the bill. Failure to produce such items, no payment will be released.
- h) The pest controlling exercise is to be undertaken on daily basis under the supervision of NKDA officials

#### 10) MODE OF SELECTION

The selected bidder has to submit the Earnest money which was uploaded at the time of Bidding, within 7 days from the date of declaration of lowest.

If the selected bidder fails, then authority will decide if the second lowest bidder will be offered or the stretch be re-tendered. It won't be automatic choice that the second bidder or there after establish the claim.

The evaluation of the Technical bids will be carried out in the following manner:

- (i) Technical Bids will be evaluated of only those bidders who fulfil the eligibility Criteria.
- (ii) Required document list.
- (iii) Past experiences.

#### 11) MODE OF PAYMENT

Payment to the successful bidder shall be released on monthly basis on submission of Log Book/Working Report duly signed by authorized officials.

#### 12) Opening of Tender:

Tender shall be opened as per Date and Time Schedule. In case Tender opening date is declared HOLIDAY, Tender shall be received and opened on next working day at the same time specified in the NIT (Notice Inviting Tender).

- 13) The successful bidder whose bid is accepted shall make formal agreement along with bid documents in triplicate, within 7 (seven) days from the date of issue of LOI by Administrative Officer-II, New Town Kolkata Development Authority. If the successful bidder fails to perform the formalities within the specified period the Tender is liable to be cancelled and the Bid Security will be forfeited.
