- 2) Both Technical Bid and Financial Bid (with documents as in Para-12) are to be submitted concurrently, duly digitally signed, in the website <a href="http://wbtenders.gov.in">http://wbtenders.gov.in</a>. as per the Date & Time Schedule at Para-19of this NIET.
- 3) The FINANCIAL OFFER of the prospective qualified tenderer(s) will be considered only if the TECHNICAL BID of the tenderer(s) is found qualified by competent authority of New Town Kolkata Development Authority. The decision of the competent authority of New Town Kolkata Development Authority will be final and absolute in this respect. The list of Qualified Bidders will be displayed in the website.
- 4) Conditional bids, incomplete bids or bids with deviation from any of the conditions stipulated in the e-tender will be liable to be rejected and earnest money will be forfeited.
- 5) Bidder shall not be permitted to withdraw his offer or modify the terms and condition once bid is submitted. In case the bidder fails to observe and comply with the stipulations made herein or back out after quoting the rates, earnest money will be forfeited.
- 6) The e-tender inviting and accepting authority will determine the eligibility of each bidder and reserves the right to reject all or any of the tenders without assigning any reason thereof.
- 7) Corrigendum/Amendment to the e-tender will be made if required which will be part & parcel of this e-Tender.
- 8) The successful tenderer whose tender is accepted shall make formal agreement along with bid documents in triplicate within 7 (seven) days of issuance of LoI to successful tenderer.

### 9) Eligibility Criteria:

- a. The bidder shall have an experience of at least 1(One) year or more. The bidder should submit a work completion/ performance certificate with at least work value of Rs.500000/-(Rupees five lakh) for the last Financial Year in Mosquito Control activities from any Govt. Departments/ PSUs/any other reputed organizations. The bids received without prescribed performance certificate may be rejected.
- b. The bidder should have a valid licence to stock and use of permissible insecticide for commercial pest control operation.
- c. The bidders shall have to submit their audited financial statement / audited annual report of the last financial years.
- d. The bidders should be able to provide required number of sets of both sprayer and fogging machines per day. Adequate Manpower should be available for providing such services.

#### 10) Earnest Money Deposit (EMD)

The bidder shall furnish an amount of Rs.1,00,000/- (Rupees One lakh) only as Earnest Money by way of Net Banking through ICICI payment Gateway/ NEFT/RTGS which shall be converted into the Security Deposit and to be refunded on expiry of contract period. The said Security Deposit will be forfeited if the contractor fails to perform his contractual duties satisfactorily. In case the NIeT is required to be re-invited, the existing EMD may be submitted.

- c) Area to be covered: Entire area under jurisdiction of NKDA.
- d) Spaying / Fogging to be done on regular basis even on holidays as per weekly calendar/schedule to be provided by NKDA.
- d) Images to be captured for each pest control locations and to submit to concerned whatsapp no.
- e) Work done certificate from Authorized representative of the location/ area/ housing complex/ Supervisor of NKDA is required to be submitted on daily basis. Job completion certificates and images (in DVD format) to be submitted along the bill. Failure to produce such items, no payment will be released.
- g) The pest controlling exercise is to be undertaken on daily basis under the supervision of NKDA officials.
- h) Team leads of the each group of agency have to provide a smart phone with internet (mobile data) connectivity. Internet connectivity should be available during the working period.
- i) The average ratio considered as follows:
  - Spraying: 5 Litre of the mixture per hour for an area of 250 Sqm.
  - Fumigation: 5 Litre of the of the mixture per hour for an area of 250 Sqm.
- j) Bidder have to quote the rate for each item per labour with spray / fogging machine / per hour basis.

### 14) MODE OF PAYMENT

Payment to the successful bidder shall be released on monthly basis on submission of certified Bills along with Log Book/ Working Report duly signed by authorized officials.

## 15) Opening of Tender:

Tender shall be opened as per Date and Time Schedule mentioned in Para-19 hereinafter. In case Tender opening date is declared HOLIDAY, Tender shall be opened on next working day at the same time specified in the NIeT (Notice Inviting e-Tender).

- The successful bidder whose bid is accepted shall make formal agreement within 7 (seven) days from the date of issue of Letter of Intent by New Town Kolkata Development Authority. If the successful bidder fails to perform the formalities within the specified period the Tender is liable to be cancelled and the Bid Security will be forfeited.
