4. GENERAL CONDITIONS

- 4.1. The sealed bidding documents should be dropped in the Tender Box at NTBC office on or before the stipulated date and time. The envelope should be sealed and delivered to the General Manager, New Town Business Club, Street-90, Action Area-1A, Block-AE, New Town, Kolkata-700156.
- 4.2. Each page of the documents must be stamped and signed by the person or authorised persons submitting the bid in token of his/her having acquainted himself/themselves and accepted the entire documents including various conditions of contract. Any Bid with any of the Documents not so signed is liable to be rejected at the discretion of the Authority. NO PAGE SHOULD BE REMOVED/DETACHED FROM THIS BIDDING DOCUMENTS.
- 4.3. The bidder shall attach the copy of the authorisation letter/power of Attorney as the proof of authorisation for signing on behalf of the Bidder whenever so applicable.
- 4.4. All bidders are hereby explicitly informed that conditional offers or offers with deviation from the conditions of contract, the bids not meeting the minimum eligibility criteria. Conditional tender will not be entertained and shall be deemed as 'informal'.
- 4.5. Bidders shall not be permitted to withdraw his offer or modify the terms and conditions thereof.
- 4.6. Validity of the bids: The quoted bids shall have the validity for a period of 01 (one) year from the date of opening of the tenderers.
- 4.7. Opening of bids: The tenderer either himself or may authorise any person to be present at the time of opening of the bids.
- 4.8. Right of Acceptance: NKDA reserves all rights to reject any or all bids without assigning any reason.
- 4.9. Corrigendum/Amendment to the NIQ will be effected if required.
- 4.10. Bidders sending their bids through courier/by Speed Post should also ensure that their bids are received on the said addresses by the stipulated date and time. No time extension for courier/Speed Post/by Person shall be granted.

MINIMUM ELEGIBILITY CRITERIA

- 5.1 The Bidder should have a PAN issued by the Income Tax Department.
- 5.2 The agency should have minimum experience in conducting training of badminton at the time of submitting the bid.

 - 11.1. If the Authority not satisfied with the performance of the manpower, then new manpower required to be replaced within 7 (seven) days, failure of that contract will be terminated.
 - 11.2. NKDA may terminate the contract due to any reason, by issuing a notice of 15 days.
