- 4. The undersigned reserves the right to accept or to reject any or all the tender papers without assigning any reason whatsoever and not bound to accept even the lowest one.
- 5. Firms/Suppliers/Distributors taking part in the call should possess GST Registration Number.
- Tender Form in WBF 2908 along with schedule of work will be had from the office of NTBC upto 5-30 p.m. dated 00-10-2018 on payment of Rs.102.00 (Rupees One Hundred and Two) only in cash.
- 7. The lowest tenderer or whose rate will be accepted by the authority of NTBC shall have to execute agreement in WBF 2908 in duplicate on payment of Rs.102.00 per set failing which work order will not be issued.
- 8. The lowest tenderer will have either to deposit or agree to deduct an amount equal to 10% value of the bid as Security Deposit which shall be retained with New Town Kolkata Development Authority during the whole time of defect liability period.
