- 4) Technical Bid will contain 70 marks. Financial bid of only the bidders securing 30 qualifying marks in technical evaluation, shall be opened for financial evaluation. Financial Bid containing 30 marks. Highest score to the least cost bidder and proportionately lower score for higher cost bidders will be awarded. Final marks will be calculated based on total of Technical and Financial scores.
