New Town Kolkata Development Authority (NKDA), invites sealed bids from registered Companies / firms having experience in SMS gateway service for "Providing BULK PULL/PUSH SMSs for the New Town Kolkata Development Authority".

#### **Bidding Procedure**

The prescribed tender documents consisting of

- (i) Technical Bid and
- (ii) Financial Bid

#### **Technical Bid**

Technical bid should contain all the technical specifications, recommendations and other details as mentioned in Annexure-C deem fit by the SMS gateway provider to evaluate their capability of undertaking the work. The vendors will be first assessed based on the Company Profile having various factors related to their Technical Specification, area of expertise and their understanding of the work and demonstrating their capability to successfully execute the work. Service Provider who may not be able to demonstrate their understanding / capability will be rejected from the process of further evaluation.

#### **Financial Bid**

For successfully selected developers, the financial bid shall be opened and compared for financial proposals.

### Scope of Work

- 1. Push & Pull SMS services for subscribers of all mobile service providers.
- 2. An audit trail showing all outgoing SMS's must be produced, also giving a hash total of the number of cell phones SMS'd and unsuccessful sms's and reason for unsuccessful sms.
- 3. Sender-ID should contain identity of sender.
- 4. Service Provider will help this Authority to configure their.
- 5. The bidder should provide API and support in integrating PULL/PUSH SMS Service with this Authority application.

## **Solution Requirements**

- a) Vertical and horizontal scalability.
- b) Adaptability.
- c) Flexibility.
- d) Cost-effectiveness.
- e) High Performance in terms of speed, reliability and delivery. .

- f) There must be a mechanism to build business rules (business rule builder) to be used to generate SMS's. These business rules must be able to be triggered automatically and manually. The solution must also be able to handle complex business rules.
- g) Securely send batches of SMS messages.
- h) Confidentiality of data.
- i) Access to all CDMA/GSM networks nationally.
- j) Secure encrypted connection with guaranteed delivery.
- k) Ease of customization.
- I) Ability to integrate with the NKDA web application system.

#### **Instructions to Bidders**

- 1) Registered Companies / firms having experience in software development are eligible to submit bid.
- 2) The tender documents can be downloaded from NKDA website (<a href="http://www.nkdamar.org">http://www.nkdamar.org</a>).
- 3) Only enclosed formats as provided in original should be used. All sheets need to be submitted after affixing seal of the Company/firm and signature of the authorized signatory conveying acceptance of all terms and conditions of this tender.
- 4) The prescribed tender document consisting of (i) Technical Bid and (ii) Financial Bid, sealed separately in two different envelopes, superscribing "Technical Bid" and "Financial Bid", and placed in a duly sealed big single envelope superscribing "Providing BULK PULL/PUSH SMSs for the New Town Kolkata Development Authority", may be submitted by hand/by Speed Post to office of "New Town Kolkata Development Authority, 03 MAR, New Town Kolkata-700156" so as to reach within the scheduled date and time.
- 5) Financial bid will be opened only for those bidders who will qualify on the basis of technical Bids.
- 6) The bidder shall quote the price of the complete project inclusive of all taxes and duties.
- 7) No price escalation will be allowed.

#### **Other Conditions of Contract**

- 1) Tenderer should have at least 5 years of experience in the SMS gateway service provider and minimum Turnover of Rs. 30 lacs (last financial Year).
- 2) The bidder should have executed at least one order of at least 1 lakhs SMS package in the previous financial year. The bidder should have provided SMS services (Push & Pull) to a minimum of five organizations of which at least two entities should be Government Institutions

- 3) To assist the examination, evaluation and comparison of bids, NKDA, may at its discretion ask the bidder for clarification of its bid including price. The request for clarification and the response shall be in writing.
- 4) **Terms of Delivery:** The SMS services shall be enabled within 21 days of acceptance of the Work Order which includes integration with NKDA existing system.
- 5) 10% as Security Deposit of will be deducted from the bill. The said Security Deposit will be retained till the support and maintenance period is over.
- 6) Taxes and duties as applicable will be deducted from the bill.

#### 7) Payment terms:

- a) Registration Charges for Short Code will be made in after successful acceptance of the Service.
- b) Bill will be submitted by the Bidder on quarterly basis of submission of bills duly supported by the system log with the performance report from the concerned user prepared every month.
- c) The SMS not delivered under error codes pertaining to mobile switch off / not reachable / memory cap full will be assumed as delivered. Rest all error codes would be considered as not delivered and not chargeable.
- 8) **Maintenance**: The vendor shall maintain the application for 01 (One) year after the date of implementation.
- 9) NKDA reserves the right to accept or reject any offers without assigning any reason thereof, and to amend the terms and conditions at time of the work.
- 10) Documents to be submitted: Interested vendors eligible shall furnish the following documents along with Technical Bid:
  - a) Company Profile
  - b) Write up on company's experience as a provider for software solutions
  - c) Details of similar and relevant projects handled
  - d) Audited financial statement to show work undertaken in last year.
  - e) Certificate of work undertaken from the agency or department.
  - f) Latest VAT and/or Professional Tax clearance certificate of firm.
  - g) Financial bid should be enclosed in a separate sealed envelope.
