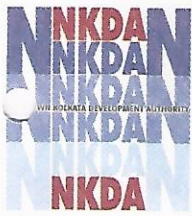

Before Scope of Work (Clause -1)	-	<u>Design Brief & Project Vision –</u> A sensory garden is a garden or other plot specifically created to be accessible and enjoyable to visitors, both disabled and non – disabled. The purpose of such a provision is to provide individual and combined sensory opportunities for the users such that they may not normally experience. A sensory garden, for example, may contain features accessible to the disabled individual such as: scented and edible plants, sculptures and sculpted handrails, water features designed to make sound and play over the hands, textured touch pads, magnifying glass screens, braille and audio induction loop descriptions. Depending on the user group, other provisions may integrate sound and music more centrally to combine the play needs of younger users with their sensory needs. Many sensory gardens devote themselves to providing experience for multiple senses; those specializing in scent are sometimes called scented gardens, those specializing in music/ sound are sound gardens where the equipment doubles up to provides an enhanced opportunity for strategic developmental, learning and
