All the bidders will have to submit On-line Earnest Money & necessary Earnest Money will be deposited by the bidder through the following payment mode as per Finance Department Order No. 3975-F(Y) dated 28<sup>th</sup> July, 2016 (Annexure-A).
  - (i) **Net Banking** (any of the banks listed in the ICICI Bank Payment gateway) in case of payment through ICICI bank payment gateway.
  - (ii) RTGS / NEFT through bank account in any bank. The EMD shall be deposited in favour of "New Town Kolkata Development Authority" payable at "Kolkata".
- 2) Both **Technical Bid** and **Financial Bid** are to be submitted concurrently duly digitally signed in the website <a href="http://wbtender.gov.in">http://wbtender.gov.in</a>.
- 3) Tender documents may be downloaded from the website and submission of Technical Bid and Financial Bid will be done as per Time Schedule stated in Sl. No. 20 of this NIeT.

4) NKDA will not be held responsible for making payment against any anticipated profit and/or compensation for any losses or price escalation whatsoever for the works as stated of this EOI. Rates should be quoted accordingly

5) Manpower Requirement

- a) 01 One full time Live Stock Development Assistant/Supervisor/ Office Assistant.
- b) 03 (three) Multi Tusk Workers (MTW) having expertise in Dog caring for 3 shifts of 8 hours eachround the clock.
- c) 02 (two) Personnel for sweeping Caring, cleaning, and burial work.

# 6) <u>Pet Keeping in the Crèche-:</u>

a) Fees to be paid in advance

Fee- a) Rs 500 per day for small Breed and (b) Rs 750/- per day for Large Breed for the days to be kept in the Creche

#### b) Security Deposit

Advance payment of Security deposit is to be made for total period of stay Rs 10,000/-(Refundable at the time of release of Dog after adjustment of all expenses).

## 7) Conditions for keeping Pet Dog.

The Veterinary Doctor from NKDA will verify the following before Admission/Registration of dog

- a) No infected or sick pet dog will be received Fit certificate from a Registered Veterinary Doctor must be submitted. The fit Certificate must clearly mention that the pet dog is not infected with any skin disease or any other disease.
- b) Copy of document of last Vaccination (Vaccination Card) should be produced
- c) Copy of prescription for routine medications of the Pet Dog from registered Veterinary Doctor to be submitted along with the required Medicines for total period of stay
- d) In case of death of the pet dog during stay at creche, the Authority will not be responsible. However, in case of death due to illness, all records of treatment with report of the Veterinary Doctor of NKDA will be kept in records.
- d) No food will be allowed from the Owner of the Dog from outside

## 8) **PET CEMETERY**

Photocopy of Death Certificate issued by a Recognized Veterinary Doctor must be submitted at the of registration for burial of a Pet dog in the Cemetery Fees of Rs 2500/- (Two thousand fivehundred) will be charged for the purpose.

A suitable ApplicationForm will be devised for Pet Dog Creche and Pet Dog Cemetery.

### 9) Stake of NKDA

## New Town Kolkata Dev. Authority will provide

- a) Full infrastructural facility including Instruments (as per agreement)
- b) Deployment of one Supervisor/Junior Office Asst.
- c) Engagement of Round the clock Security Personnel
- d) Payment of Electricity Bills
- e) Collection of all types of Fees/Charges

#### 10) Scope of Work of the Agency.

The Agency will provide

- a) One full Time Live Stock Development Assistant/Supervisor/Office Asst with experience in Govt. /Reputed Private Organization.
- b) Threemulti-taskworkers having expertise in Dog-keeping for caring round the clock (1 for each shift).
- c) Two sweeper-cum-Caring and burial work Staff.
- d) All recurring expenditure for Human Resource for burial work, etc., cost of Food including food. Hygienic ItemsPurchase of Medicine & Publicity.
- e) The agency on their part will place the claim to the Authority for incurring expenditure for running Pet Dog Creche smoothly and **Quote Yearly Bid** amount for three years
- f) Engagement period of the Agency will be for 03 (three) years.

### 11) **ELEGIBILITY FOR PARTICIPATION IN E.O.I**

Registered. Bona fide, reliable, and resourceful Organization/ Agencies/ Society/ Co-operative Society/ Person having experience in dealing animals or similar type of work or, having at least one Veterinary professional in the management or having similar activity in the objective in MOA/Byelaws mayparticipate in this Expression of Interest (EOI)

Intending Bidder may download the Tender Documents from the website <a href="http://wbtenders.gov.in">http://wbtenders.gov.in</a>. All the Bidders will have to submit earnest Money, which may be remitted online in favor of "New TownKolkata Development Authority" payable at Kolkata and also to be documented through e-filing both Technical Bid and Financial Bid are to be submitted concurrently duly digitally signed in thetender Documents may be Download from website and submission of Technical Bid & Financial Bid will be done as per time schedule of this EOI.

The Financial Offer of the prospective qualified Tenderer(s) will be considered only if the Technical Bid of the Tenderer(s) is found qualified by the competent Authority of New Town Kolkata Development Authority. The decision of the competent Authority will be final and absolute in this respect The list of Qualified Bidders will be notified on the website after evaluation of Technical Bids.

#### Joint Ventures/MOU will not be allowed.

- 12) Income Tax, GST and others Taxes as admissible will be deducted as per Govt. orders issued from time to time and would be applicable on the date of making payment of the bills. Building & other construction worker's Cess @ 1.0% will be deducted from progressive bills in pursuance with G.O. no. 599A/4M 28 / 06 dated 27/09/2006. The rate quoted would remain same throughout the period of contract and should be inclusive of **all taxes** which are and will also be applicable during the entire tenure of the contract.
- 13) Mobilization advance, time / cost over run and consequent cost escalation for any material, labour, etc. will not be allowed

# 14) **Earnest Money Deposit (EMD)**

The Bidder shall furnish an amount of **Rs 30,000/-(Rupees thirty thousand)** only as Earnest Money by Online Payment in favor of "**New Town Kolkata Development Authority**" payable at Kolkata&balance amount to cover **2**% (Two percent) of Earnest Money in the shape of Demand Draft / Bankers Cheque drawn on any Scheduled Bank in India in favour of **New Town Kolkata Development Authority** which will be converted into the Security Deposit (10% of the Bid amount) and to be refunded on expiry of contract period. The said Security Deposit will be forfeited if the Agency fails to perform his contractual duties satisfactorily.

- b) Folder for **Technical Bid** should contain detailed proposal for running Pet dog creche including detail plan and details for deployment of manpower. Besides this all the statutory documents (as mentioned in Para-9)
- c) Financial bid in respect of Pet Dog Creche with detail of financial proposal must bemarked with "Financial Bid of the Pet dog Creche & Pet dog Cemetery".

Any bidder not following the above steps in submitting the bid/Offer shall be disqualified

### 18) MODE OF SELECTION.

The applicant or bidder who will quote the **Lowest Rate** will be offered to run the Pet Dog Creche and Pet Dog Cemetery. The Agency must offer their rates in the Items provided in the BOQ as per minimum wages last circulated by Labor Welfare Department.

### 19) **MODE OF PAYMENT.**

Successful bidder will prefer claim on monthly basis after end of each month.
