Applications are hereby invited from **eligible female candidates** for the engagement of **15 (fifteen) Honorary Health Workers** on an honorary basis to assist in community-level health and outreach activities within the jurisdiction of **New Town Kolkata Development Authority (NKDA)**, as per details given below:

1.	Name of the Position	:	Honorary Health Worker
2.	Period of engagement	:	Initially for 01 (One) year. The contract can be extended further depending on assessment of performance, mutual willingness and depending on the requirement. The contract may be terminated on one month's notice from either side or on payment of one month's pay in lieu thereof. Unauthorized absence may lead to termination of the engagement.
3.	Monthly Honorarium	:	₹5,250/- (Rupees five thousand two hundred fifty only), subject to revision as per applicable norms.
4.	Nature of Duties	:	To work as Health Workers in the community to create awareness of health, to mobilize the populace, specially the economically weaker community, towards local health planning and increase utilization and accountability of the existing health services by implementing family planning and immunization programmes, assisting pregnant mothers and new born children to enable them to avail themselves of the health services etc. as per the guidelines of the Government issued from time to time.
