Whereas it is necessary for the interest of public safety and convenience, in exercise of power vested with the New Town Kolkata Development Authority under Section 50(1) of New Town Kolkata Development Authority Act 2007 it is hereby notified that the following roads / stretches / carriageway will be NKDA "Fee Parking" zones as per time schedule noted against each under New Town Kolkata Development Authority (NKDA).
