NOTIFICATION

In exercise of the power conferred by sub-section (1), read with sub-section (2aa), of section 138, of the West Bengal Town and Country Planning (Planning and Development) Act, 1979 (West Ben. Act XIII of 1979), the Governor is pleased hereby to make, with immediate effect, the following amendments in the New Town Kolkata Planning Area (Buildings) Rules, 2014, published with this Department notification No. 698-UD/O/M/HID/4I-03/2013 (Pt.), dated the 4,h March, 2014, published in the *Kolkata Gazette, Extraordinary*, PART I, dated the 4th March, 2016 (hereinafter referred to as the said rules):—

Amendments

In the said rules. —

(1) in Chapter 1, in rule 8 (D), to sub-rule (1), add the following provisos:—

"Provided that in case of a land area upto 200 sq. metre, mandatory open space in front or side or both, as the case may be, subject to such minimum space, shall be maintained from the original property line before allowing of such gift and in case of strip of land is required to be gifted to make the width of the means of access 1.75 metre from the center of line of the said means of access, the same may be made subject to the condition that the foundation of the building is not encroached:

Provided further that if the gifting of the proposed strip of land or relinquishing is not practicable for widening of street or passage, the Floor area ratio (FAR) shall be reduced by 20 % of the value as shown in Table VIII of rule 27.";
