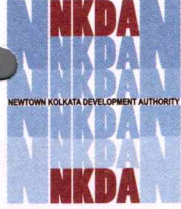

NOTIFICATION OF NEW VEHICLE PARKING ZONES UNDER NEW TOWN KOLKATA DEVELOPMENT AUTHORITY

Whereas it is necessary for the interest of public safety and convenience, in exercise of power vested with the New Town Kolkata Development Authority under Section 50(1) of New Town Kolkata Development Authority Act 2007 it is hereby notified that in addition to parking zones notified vide earlier notifications, the following roads / stretches / carriageway will be NKDA "Fee Parking" zones as per time schedule noted against each under New Town Kolkata Development Authority (NKDA). This order shall come into force with immediate effect and continue until further order:-

714	North side of Southern Service Lane on Street No 714 onwards to street No. 716 From crossing of Eco Space island to the West to crossing of street no. 795 to the East .	24 hours	Heavy passenger 4 wheelers parallel to kerb
714	South side of Northern Service lane on Street No 714 onwards to street No. 716 From crossing of Eco Space island to the West to crossing of street no. 795 to the East.	24 hours	Heavy passenger 4 wheelers parallel to kerb
331	Both sides of street No. 331 parallel to kerb from crossing of street No. 372 to the North to crossing of street No, 376 to the South till organized parking lot is developed.	24 hours	Heavy passenger 4 wheelers parallel to kerb till parking lot on street 372 is developed

394	Street No. 394 from crossing of street No. 374 to crossing of street No. 361 both sides of Carriageway adjacent to pavement. Demarcated space to be left for free parking of 10 light four wheelers in front of Coffee House premises	24 hours	Two wheelers and light four wheelers parallel to kerb in general and perpendicular to kerb in off carriageway parking space in front of Amity University
3333	on Both sides of street 3333 from periphery canal to the East to DJ 16 (Shankara Nethralaya) to the West between Property Line and Pavement	24 hours	Two wheelers and light four wheelers perpendicular to kerb in the space between property line and pavement

Parking of vehicles should be made without obstructing flow of traffic on the carriageway and without obstructing the ingress and egress to plots/premises/property abutting the street. No Parking allowed within 5 meters of street crossings. Parking should be made in accordance with traffic rules and as guided by police as well as NKDA officials. NKDA reserves the right to change or relocate the parking zones at their discretion.
