**Revised terms of Renewal:**

- (a) After completion of financial year, the certificate shall have to be renewed by its holder, on submission of an application along with the renewal fee not exceeding the proposed fee (i.e., Rupees 2,500/-, if approved) only for those professions, trades and calling where license fee is (to be amended U/S 36A, if done) equal to or more than the proposed fee (i.e., Rupees 2,500/-, if approved), arising out of corresponding existing fee amounting to Rupees 500/-.
- (b) Renewal fee has to be paid at the rate of same rate at which an applicant is required to pay the fee for enlistment (to be amended U/S 36A, if done) for those professions, trades and calling where license fee is less than proposed fee (i.e., Rupees 2,500/-, if approved).
- (c) A fine amounting to half of the proposed fee(s) for enlistment (i.e., Rupees-25,000/-, Rupees-20,000, Rupees-15,000/-, Rupees-10,000/-, Rupees-7,500/-, Rupees- 5,000/-, Rupees-2,500/-, Rupees- 1,500/- and Rupees-1,250/- etc., as the case may be, if approved), will be charged if the enlistment is renewed after 15 days and within 60 days of the date of its expiry.
