

NOTICE INVITING ITEM RATE e-TENDER

Notice Inviting e-Tender No.05/NKDA/SE-ELEC/2025-26

The Superintending Engineer, New Town Kolkata Development Authority invites item rate e-Tender from resourceful, reliable, bona-fide and experienced OEM or their authorized Distributor working under KMDA, NKDA, WB HIDCO, KMC and other Govt. Departments / PSU having experience in supply of different types of switches, sockets, MCBs etc are requested to submit their offer for the work detailed below.

All the bidders will have to submit On-line Earnest Money & necessary Earnest Money will be deposited by the bidder through the following payment mode as per Finance Department Order No. 3975-F(Y) dated 28th July, 2016 (Annexure-A).
 - (i) **Net Banking** (any of the banks listed in the ICICI Bank Payment gateway) in case of payment through ICICI bank payment gateway.
 - (ii) **RTGS / NEFT** through bank account in any bank. The EMD shall be deposited in favour of “**New Town Kolkata Development Authority**” payable at “**Kolkata**”.
- 3) Both **Technical Bid** and **Financial Bid** are to be submitted concurrently duly digitally signed in the website <http://etender.wb.nic.in>
- 4) Tender documents may be downloaded from website and submission of Technical Bid and Financial Bid will be done as per Time Schedule stated.
- 5) The **FINANCIAL OFFER** of the prospective tenderer will be considered only if the **TECHNICAL BID** of the tenderer is found qualified by the ‘Tender Evaluation Committee’ formed by the authority of NKDA. The decision of the ‘Tender Evaluation Committee’ will be final and absolute in this respect. The list of Qualified Bidders will be displayed in the website.

7) The prospective bidders shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. (A declaration in this respect through affidavit has to be furnished by the prospective bidders without which the Technical Bid shall be treated as non-responsive.)

8) **Annual Turnover:** The organization should preferably have an average annual turnover of **Rs. 200 (Two hundred) lakhs** during last three financial years. A certified document issued by a chartered accountant stating the average annual turnover of the bidder has to be submitted.

9) Joint Ventures will not be allowed. A prospective bidder shall be allowed to participate in a particular job either in the capacity of individual or as a partner of a firm. If found to have applied severally in a single job, all his applications will be rejected for that job, without assigning any reason thereof.

10) The prospective bidders should or any of their constituent should not be debarred to participate in any tender or black listed by any tender inviting authority during the last 5 (five) years. A declaration in this respect thorough Affidavit should have to be submitted by the prospective bidder in non-judicial stamp.

11) The Manufacturer of reputed Brand having NABL laboratories or the authorized distributor of the manufacturer (duly authorized by the Manufacturer mentioning tender no and name of work) are eligible to participate in the Tender.

12) The OEM authorization letter of tender specified OEM at least of a brand should be included with a technical bid & OEM should have serviced by the bidder.

13) The OEM authorization letter of tender specified OEM at least of a brand should be included with a technical bid & OEM should have serviced by the bidder

14) A declaration of warrantee of Items as per tender from an OEM shall have to be submitted by the bidder through an AFFIDAVIT on Govt. Stamp paper. and distributor must be minimum five years old.

15) OEM have their own manufacturing unit for manufacturing switches, sockets, MCBs etc, necessary documents as mandatory to be submitted along with the technical bid & must be BIS certified.

16) Agency only having valid documents as per check list will upload the documents. Any act. of uploading invalid documents to disturb the tendering process will be viewed administratively & legally.

17) A prospective bidder shall be allowed to participate in a particular job either in the capacity of individual or as a partner of a firm. If found to have applied severally in a single job, all his applications will be rejected for that job, without assigning any reason thereof.

18) No mobilization advance and secured advance will be allowed.

19) **Security Deposit:** Retention money towards Security deposit @10% (2% EMD + 8% additional from bill) on gross payment will be deducted from the bill. EMD will be converted to Security Deposit for the successful bidder.

20) All materials required for the proposed work shall be of specified grade in conformity with relevant code of practice (latest revision) accordingly and shall be supplied by the agency at their own cost including all taxes.

21) There shall be no provision of Arbitration.

22) Bid shall remain valid for a period not less than 180 (*one hundred eighty*) days from the last date of submission of Financial Bid / Sealed Bid. If the bidder withdraws the bid during the validity period of bid, the earnest money as deposited will be forfeited forthwith without assigning any reason thereof.

23) The Quantity mentioned in BOQ is tentative, it may vary as per actual requirement according to the instruction of EIC.

25) The quantity of each individual items may vary according to the actual requirement and/or subsequent augmentation of the site. Payment would be made on the basis of actual quantity supplied without any price escalation.

26) On-going payments for work may be allowed to the executing agency as per existing rules and availability of fund subject to deduction of security deposit. Progressive payment may be made against the completed or partly completed item of works. Such interim payments, shall be made as running account bill (s), however, shall not construed to mean that the respective items / components have finally been approved and accepted by NKDA and the supplier shall not be absolved of his responsibility to set right any deficiency of such paid items / components at his/ their own cost, for rectifying all defects which are subsequently being noted or found.

28) Refund of Security Deposit (full) will be made after 05 (Five) years from the date of Completion of Work. Partial release to be made in the following manner: - 1st 3 years - NIL, 4th year - 30 % of the security deposit, 5th year - balance 70%.

29) The supplier is liable to change all defective/non-functional items within 5 years from the date of supply at his own cost.

30) Site of work may be handed over to the agency phase wise. No claim in this regard will be entertained.

31) Earnest Money 1.0 lakh to be deposited online through e-tender portal payment gateway. Balance earnest money equivalent to 2% of the quoted rate (if any) to be deposited by the L1 bidder only.

32) The Bidder, at his own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all information's that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender, before submitting offer with full satisfaction, the cost of visiting the site shall be at his own expense.

33) The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the Department. The tender accepting authority of NKDA, reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Tenderer at the stage of Bidding.

34) **Specification of materials:** - Specification of materials to be supplied is given in Appendix "A". The bidders are requested to quote accordingly.

35) Failure to submit hard copy with the acceptance latter with the time period prescribed

for this purpose may be construed as an attempt to disturb the tendering process and dealt with accordingly legally including black listing of the bidder.

36) Conditional / Incomplete tender will not be accepted under any circumstances.

37) The intending tenderers are required to quote the rate online.

38) During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, then bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.

39) The Superintending Engineer, NKDA reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.

40) If there be any objection regarding prequalifying the Agency that should be lodged on line to the Tender inviting authority within 24 hrs from the date of publication of list of qualified agencies and beyond that time schedule, no objection will be entertained by the Tender Evaluation Committee.

41) Before issuance of the WORK ORDER, the tender inviting authority may verify the credential and other documents of the lowest tenderer if found necessary. After verification if it is found that the documents submitted by the lowest tenderer is either manufactured or false in that case work order will not be issued in favour of the said Tenderer and his EMD will be forfeited followed by black-listing of his firm.

42) The successful Tenderer whose tender is accepted shall make formal agreement in WBF 2908 along with bid documents in triplicate will be available at office on payment of, **Rs. 2955/- (Rupees Two Thousand Nine Hundred Fifty Five only)**, within 7 (seven) days from the date of issue of LOI cum acceptance order by Superintending Engineer, New Town Kolkata Development Authority on payment of usual charges which is non-refundable under any circumstances and submit the same duly signed by him/them to this office. If the contractor fails to perform the formalities within the specified period the Tender is liable to be cancelled and the Earnest Money will be forfeited as per relevant clauses under memorandum of WBF 2908.

43) If any discrepancy arises between two similar clauses on different notification, the clause as stated in later notification will supersede former one in following sequence:

- a. Form No. 2908
- b. N.I.T.
- c. Specification
- d. Technical Bid
- e. Financial Bid
- f. General Terms & Conditions

44) The intending Bidder are requested to attend the prebid meeting to discuss the matter relates to any dispute/proposal with proper documents whatsoever. No dispute/proposal or objection regarding technical specification would be entertained after the prebid meeting.

45) Escalation of Price on any ground and consequent cost over run shall not be entertained under any circumstances. Rates should be quoted accordingly

46) Tender Evaluation Committee (TEC)

Evaluation Committee constituted by the Competent Authority of NKDA will function as Evaluation Committee for selection of technically qualified contractors.

47) Opening of Technical Proposal:

Technical proposals will be opened by the Concerned Tender Inviting Authority or his authorized representative electronically from the website using their Digital Signature Certificate (DSC). Summary list of technically qualified tenderers will be uploaded online. During evaluation the committee may summon of the Bidder(s) & seek clarification / information or original hard copy of any of the documents already submitted & if these are not produced within the stipulated time frame, their proposals will be liable for rejection.



53) Award of Contract

The Bidder whose Bid has been accepted will be notified by the Tender Inviting & Accepting Authority through acceptance letter / Letter of Acceptance. The notification of award will constitute the formation of the Contract. The Agreement in Form No. 2908 will incorporate all agreements between the Tender Accepting Authority and the successful bidder. All the tender documents including N.I.T., Corrigendum & B.O.Q. will be the part of the contract documents. After receipt of Letter of Acceptance and work order, the successful bidder shall make formal agreement in BWF 2908 in triplicate which will be available at office on payment of **Rs. 2955/- (Rupees Two Thousand Nine Hundred Fifty Five only)** for each set, required cost shall be deposited by the supplier to the Canara Bank, Newtown Branch in favour of the NKDA within time limit to be set in the letter of acceptance or in work order.



2. MCB's should be 240/415 Volt, C Characteristic, and breaking capacity 10 kA. Capacity of MCB's to be mentioned against respective items in BOQ.
3. MCCB's should be 415 Volt, 4 Pole, Fixed thermal and fixed magnetic /adjustable thermal and fixed magnetic, breaking capacity 25/35 kA. Capacity of MCCB's to be mentioned against respective items in BOQ.
4. MCB SS enclosure should be powder coated with IP-20/30 protection. Numbers of way to be mentioned against respective items in BOQ.
5. MCB distribution board should be double door openable, with IP-42/43 protection. Numbers of way to be mentioned against respective items in BOQ.
6. MCB TPN distribution board horizontal type should be double door openable, with IP-42/43 protection. Numbers of way to be mentioned against respective items in BOQ.
7. MCB TPN distribution board vertical type should be double door openable, with IP-42/43 protection. Numbers of way to be mentioned against respective items in BOQ.
8. Single core copper cable should be Stranded, FR PVC insulated and unsheathed. Size of cable to be mentioned against respective items in BOQ.
9. Modular switch/socket/plug/starter etc should be 230/240 Volts. Capacity of switch/socket/plug/starter to be mentioned against respective items in BOQ.
